## O.C.G.A. § 31-7-22(b)(2)(D) Response Regarding Real Property

Please note that O.C.G.A. § 31-7-22(b)(2)(D) requires a nonprofit hospital in Georgia to post a "listing of all real property holdings of the hospital [...]."

Based on a reasonable interpretation, there are nine relevant hospitals<sup>1</sup> within the Emory Healthcare system for purposes of disclosures under O.C.G.A. § 31-7-22: Emory University Hospital,<sup>2</sup> Emory University Hospital Midtown, Emory University Orthopaedics & Spine Hospital, Emory University Hospital Smyrna, Emory Saint Joseph's Hospital, Emory Johns Creek Hospital, Emory Decatur Hospital, Emory Hillandale Hospital, and Emory Long Term Acute Care.

Currently, with limited exception, these hospitals do not own the real property on which the hospitals sit. Generally, with limited exception, the real property on which the hospitals sit is owned by Emory University, Emory/Saint Joseph's, Inc.,<sup>3</sup> or the DeKalb County Hospital Authority. However, in the interest of transparency, a general listing is included here of parcels on which the main hospital buildings<sup>4</sup> are situated on the primary hospital campuses. This listing is not a comprehensive listing of all parcels on the primary campuses nor is it a comprehensive listing of all property which may be owned by Emory University, Emory/Saint Joseph's, Inc., or the DeKalb County Hospital Authority.

This information is based on a reasonable and good faith interpretation of O.C.G.A. § 31-7-22. Because this information is specific to O.C.G.A. § 31-7-22, this information may not be directly comparable to information from other public or private reports or databases, other documents, or other reporting requirements.
